## HOUSE RESOLUTION NO. 1

## A RESOLUTION

## ON THE DEATH OF HONORABLE JOHN HUNT UDALL

The Honorable John Hunt Udall, Native Arizonan and distinguished citizen, passed away on March 3, 1959, at the age of sixty-nine years.

Mr. Udall was born in Snowflake, Arizona, on August 23, 1889, and lived his entire life in the State of Arizona. His forebears also played a prominent part in the history of Arizona and were active in the Church of Jesus Christ of Latter-day Saints. John Udall's father, David Udall, was an Apache County pioneer and also became the first president of the Arizona Temple of the Church of Jesus Christ of Latter-day Saints in Mesa. The grandfather and great-grandfather of John Hunt Udall were also individuals who distinguished themselves in their own era.

The Honorable John Hunt Udall participated actively in politics for many years. In 1914, he was elected clerk of the Apache County Superior Court. The citizens of his legislative district honored Mr. Udall by electing him to the Arizona House of Representatives. He served for two terms for the period extending from 1921 through 1924. While in the Legislature, he served with distinction and with his usual vigor and diligence.

Following his service in the Legislature, in the years 1925 and 1926, John Udall served the public in a dual capacity. Not only was he a member of the Apache County Board of Supervisors, but at the same time he served as a member of the board of trustees of St. Johns High School district. Following this service he was employed from 1926 to 1933 as Federal Prohibition Director for the State of Arizona.

In addition to his many other public offices, John Hunt Udall was city clerk for the City of Phoenix and he was also a city magistrate in Phoenix.

John Hunt Udall during his residence in Apache County established himself as a cattleman and rancher and also earned a reputation as a road builder. His activity in his church included an appointment as Bishop of the Phoenix First Ward from 1928 to 1939. Thereafter he became a member of the Phoenix Stake High Council and he held this position until 1950. Therefore

Be it resolved by the House of Representatives of the State of Arizona:

That the members of the House of Representatives do sincerely regret the passing of the Honorable John Hunt Udall and do recognize that in the death of John Hunt Udall the citizens of this State have suffered a real loss. Condolences are extended to his widow, Leah Smith Udall, and to his sons Nicholas, Earl, Reed, Jesse and Samuel.

#### A RESOLUTION

#### ON THE DEATH OF HONORABLE JAMES W. CARROLL

The Honorable James W. Carroll passed away in Tucson, Arizona, on April 2, 1959, at the age of fifty-six years.

Mr. Carroll was born on July 2, 1902, in Reynoldsville, Pennsylvania, but prior to his residence in the State of Arizona he resided for many years in Youngstown, Ohio.

The Honorable James W. Carroll made Tucson, Arizona, his home in 1937. In Tucson he was employed by the Southern Pacific Railroad and, in 1951, Mr. Carroll retired from active employment. After his retirement he was employed as advertising manager for the Labor Temple Printing Company and for a time worked for the State of Arizona in the Motor Vehicle Division of the State Highway Department.

The citizens of the Eleventh Legislative District in Pima County honored Mr. James W. Carroll by electing him as their Representative to the Arizona House of Representatives for the Twenty-second and Twenty-third Legislatures. Mr. Carroll was conscientious in his application to his legislative duties and while in the Legislature he served on the Labor, Administration, Banking and Insurance, Highways and Bridges, and the Highway Study Committees.

Mr. James W. Carroll served as state president of the Hibernians and for a period of time was employed as the national organizer for the Hibernians. Therefore
